### CONTRACT AGREEMENT

# SUPPLY AND DELIVERY OF ICT SUPPLIES, MATERIALS AND EQUIPMENT

    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract

In consideration for the sum of One Million Three Hundred Sixty-Three Thousand Four Hundred Fifty-Five Pesos Only (Php 1,363,455.00) or such other sums as may be ascertained, VOCOM ENTERPRISES agrees to supply and deliver the ICT supplies, materials, and equipment as defined in this contract within Thirty (30) calendar days from receipt of Notice to Proceed at its sole cost and expense, and to fully and faithfully furnish all, services and superintendence for the implementation of this Contract in accordance with his/her/its Bid.
- 4. CARAGA STATE UNIVERSITY Cabadbaran Campus agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. Parties agreed that contract may be modified upon written agreement/supplemental contract subject to the requirements set by R.A. 9184 and relevant laws.
- 6. For any dispute or controversy in connection with this Contract or difference between the Parties arising from the interpretation of this Contract, the Parties hereto shall, as far as practicable, settle the same amicably. In the event that such dispute or disagreement, be not resolved to their mutual satisfaction, the matter shall be submitted to arbitration in the Philippines according to the provisions of Republic Act No. 9285, otherwise known as the "Alternative Dispute Resolution Act of 2004".
